Chair James Schlender called the meeting to order at 8:30 am.

Schlender requested a moment of Reflection for Deputy Richard Welsh who passed away.

Motion by Dennis, 2nd by Buckholtz, to approve the minutes of the May 7, 2020 meeting. Motion carried

Chair Schlender read the Proclamation honoring the life and efforts of Mike Sanchez. Motion by Buckholtz, 2nd by Dennis to approve and forward to County Board. Motion carried

John Cain from Venture Architects presented his Constructability Assessment on the second courtroom options to the Committee. Motion by Buckholtz, 2nd by Dennis, to approve Plan #2. Motion carried

Attorney Rebecca Roeker presented an update on Public Health Ordinance enforcement. The Wisconsin Counties Association is forming a study group and Roeker recommends the county wait for advice from WCA. Motion by Buckholtz, 2nd by Dennis, to table until August Public Safety meeting. Motion carried

The committee resumed discussions on school bus safety for children getting on and off school buses during the school day. Ms. Sands addressed the committee concerning an incident in the Winter school district in January 2020. Chair offered to collect information from School districts, busing companies, law enforcement and concerned citizens to develop a plan of action. Two goals would come from the plan, one is to identify areas were high volume traffic and school bus stops are located and coordinate with Law enforcement to have police presence during school bus drop times, the second was to develop a county ordinance to address failure to stop for a school bus. Chair and Vice Chair Buckholtz volunteered to meet with stakeholders. Motion by Dennis, 2nd by Buckholtz, to convene a special meeting of Public Safety to discuss the safety plan. Motion carried, date to be determined.

Clerk of Court Marge Kelsey provided a written report.

Sheriff Doug Mrotek reported to the Committee. This past month dealt with several car fatalities, murder and attempted murder, dam failure and social unrest. Recently lost employee Richard Welsch, who will be missed.

Chief Joe Sajdera reported to the Committee and provided a written report. 990 calls in May.

Jail Administrator Jeff Johnson provided a jail report. Tested tornado sirens on May 11. May 2020 average daily population was 82.29 inmates; 18.59 females and 63.70 males.

Lieutenant Greg Ripczinski provided the patrol report.

Animal Control Officer Sherrie Shelton provided a written report to the Committee.

Emergency Management Director Pat Sanchez presented a written report.

Communication Specialist John Kruk provided a written report.

Coroner John Froemel provided a written report.

Ambulance Director Nate Dunston provided a written report and reported to the Committee.

The Committee discussed the Day and Time of the Public Safety Meeting. The committee agreed to table the discussion pending a review of the Board rules on lifting the cap of virtual meeting attendance. The issue will be on the Administration Committee agenda.

Covid-19 response seems to have died down somewhat, but gearing up for a potential resurgence in the fall. Continue to operate the decontamination trailer located at the Town of Hayward FD staffed by volunteers

The Sawyer County Hazard Mitigation Plan public hearing will be held on July 15th from 0900 to 1000 in the Assembly Room of the courthouse following CDC guidelines. Public is encouraged to attend. Once this is complete and any requested changes are made and approved, it will be submitted to WEM and FEMA for final approval. This plan is updated every 5 years and will list suggested mitigation projects that address county wide risks and allow for grants to be applied for to address those risks. This has been over a one-year project. Submitting the Hazmat and Computer grant this week.

Continue to handle the logistics of Covid-19 PPE requests from responders and health care agencies in Sawyer County.
